Changes & Clarifications from the Standards & Accreditation Committees

The Curriculum Handbook & Clinical Supervisor Guidelines

Classroom Educator Teaching Requirement for the Practicum

 NEW: In situations, where the Classroom Educator trainee must work in thirty-minute time blocks, s/he may conduct instruction in four thirty-minute sessions rather than three fortyminute sessions.

Associate Member Supervision

- In the "promotional/advertising contexts" section of the Warranty Associate Member form it states, "I will describe myself as 'Orton-Gillingham-trained at the Academy Associate Level, continuing to work under the supervision of a Fellow."
- NEW: The wording will be changed from "under the supervision of a Fellow..." to "under the mentorship of a Fellow..."

Clinical Supervisor

- Clinical Supervisor Guidelines 4/2014 (posted on the Academy's website, Member section)
 - The Clinical Supervisor (CS) assists a Fellow with training by helping in the supervision of trainees' practice teaching sessions. In carrying out her/his functions, a CS is directly responsible to the Fellow and is expected to follow the instructional protocol set by the Fellow. A CS serves at the will of the Fellow.
 - Requirements: A person may qualify as CS if she/he is 1) currently a member of the Academy at the Certified Level and has been for at least 2 years, and 2) is judged by the Fellow as having the professional knowledge and practice experience required to carry out the functions of a CS.
 - Practicum Observations: Subject to the direction of the Fellow, the CS may be assigned as many as 7 of the 10 practice teachings sessions required of trainees pursuing the Associate or Certified tracks. Trainees in the Orton-Gillingham Classroom Educator track are to be observed only by a Fellow or Fellow-in-Training.

- The requirements state that the Clinical Supervisor must have a minimum of 2 years experience as a Certified level practitioner.
 - NEW: However, a Fellow may appeal the 2-year requirement to the Certifying Committee,
 if an individual's experience and competence are exceptional.
- Note: The Clinical Supervisor may <u>not</u> conduct observations of the Classroom Educator trainees.
- Remember to register your Clinical Supervisor with our office, by completing and sending in the application form found in the Member section of our website.

Fellow-in-Training (Curriculum Handbook)

- Observations
 - "Up to eight of ... [10] observations may be performed by a Fellow-in-Training or a Clinical
 Supervisor who is working under the direction of the Supervising Fellow. (p. 25)
 - NEW: The Fellow-in-Training may conduct 7 of the required 10 observations of trainees at the Certified (p. 25)
 - NEW: They may also do 3 of the 5 observations for the Classroom Educator.
- Clarification of the meaning of Fellow-In-Training Supervision
 - Fellow-in-Training Curriculum Guidelines (p. 38) state, "The Fellow-in-Training is not yet accredited to perform training independently, and must teach under the direct supervision of the Fellow throughout all training."
 - NEW: Direct supervision means close monitoring of the Fellow-in-Training in all components of the process until the Fellow-in-Training has reached competency as determined by the Supervising Fellow. This clarification will be added to the Curriculum Handbook and included in the Handbook glossary.

Principal Training Fellow and Supervising Training Fellow

- The distinction between the terms Principal Training Fellow and Supervising Training Fellow as defined on page 5 of the Curriculum Handbook was considered.
 - NEW: The result was that the two terms remain unchanged, and after each definition, there will be an asterisk. Below the definitions will be the sentence, "In some cases the Principal Trainer and the Supervising Fellow are the same individual."



Accredited Training Fellow

 NEW: The Principal Training Fellow at an Accredited Academy training site will now qualify for the status of Accredited Training Fellow upon leaving their training position.

All of the above changes and updates will be made to the Handbook Curriculum and Clinical Supervisor Guideline documents on our website over the next 2 months


